

Palooza Basecamp & Eatery Inc Waiver and Release of Liability

1. I further covenant and agree not to institute any claims or legal action against Palooza Basecamp & Eatery Inc for any claim released by this Agreement. I further agree that should any claim be made against Palooza Basecamp & Eatery Inc in contravention of this Agreement, including but not limited to derivative claims, I will protect, defend and completely indemnify (reimburse) Palooza Basecamp & Eatery Inc for any such claim and expenses including attorney's fees and costs incurred by Palooza Basecamp & Eatery Inc in defending themselves or security indemnity hereunder.

2. I understand that Palooza Basecamp & Eatery Inc is not responsible for any lost, stolen, or damaged valuables or property.

3. I acknowledge that I have received and read a copy of the current rules and regulations governing the use of the facility. I agree that I will fully comply with all rules and regulations and with any amendments.

I have read the Agreement and understand that by signing the Agreement I have consented to be bound by its terms, including the waiver/release of any legal right I may have to sue Palooza Basecamp & Eatery Inc for any costs they incur because a claim or legal action is brought in violation of this Agreement. I agree any violation of the Agreement and its terms and conditions, as determined by Palooza Basecamp & Eatery Inc, will void and terminate this Agreement and may result in loss of the ability to use the facility.
